RE: Supreme Court Decision concerning MPSA No. 001-90-CAR

Gentlemen:

We advise that our counsel is in receipt of a Notice from the Supreme Court (SC) advising that in a Resolution dated January 24, 2023, the SC denied our Motion for Reconsideration of the Decision in the case entitled "Republic of the Philippines, represented by the Mines and Geosciences Bureau of the Department of Environment and Natural Resources vs. Lepanto Consolidated Mining Company and Far Southeast Gold Resources, Inc.".

The Mines and Geosciences Bureau has endorsed to the National Commission on Indigenous Peoples the application of Lepanto and Far Southeast Gold Resources, Inc. ("FSGRI") for the renewal of the subject MPSA. The Free and Prior Informed Consent process is therefore underway.

In the meantime, since the SC decision, as previously disclosed, expressly states that it is "without prejudice to their (Lepanto and FSGRI) full compliance with the requirement of the Free and Prior Informed and Written Consent requirement of the Mankayan Indigenous Cultural Communities/ Indigenous Peoples as a condition for the renewal of Mineral Production Sharing Agreement No. 001-90", Lepanto's mining operations continue.
